Queensland Transport Liaison Report:

QT is still not ready to present the internal review into of SIVS registration and operation to Combined Council for our comments. Rod has emailed QT and QT has indicated that they will either get the report to Combined Council after their internal December meeting or will have it ready by February 2008. There was significant discussion about the delay. Jim Scott moved that CC arrange a meeting with the Minister of Transport if QT do

not meet the February deadline of presenting the SIVS review recommendations to Combined Council by February: Seconded Robyn Lamb: Carried. The Secretary will coordinate the gathering of information relating to all Combined Council requests to QT for amendments/changes to the SIVS.

Australian Historic Motoring Federation:

Jim Scott advised the meeting that Qld will host the AGM of the AHMF in September 2008 and there may be a need for some assistance (workers & small amount of finances) from the Combined Council.

Public Liability Insurance:

There are no issues relating to Public Liability insurance and this item will no longer be addressed as a regular item at Combined Council meetings.

Calendar of Events

Tom Lewis distributed an updated calendar of events (copy attached to these Minutes).

General Business:

Registration: Val Sharp (Cadillac) reported that there were no problems in registering a 1899 Winton which had no previous registration records, it seems QT are a bit more flexible than they were a few months ago.

National Motoring Heritage Day: Three clubs (LAMA, Heritage Truck & BVRC) have so far offered to hold area or regional rallies or events for the National Motoring Heritage Day in 2008. Delegates were reminded to discuss with their club the option of clubs volunteering to hold regional/area events on National Motoring Heritage Day and issue an open invitation to other clubs to attend these events. The aim is to have a number of reasonably large events organised throughout the state. The Combined Council and AHMF will help publicise these events.

Income TAX: Jim Scott reported that the AHMF approach to have our clubs made exempt from income tax has not yet progressed beyond early discussions. The AHMF has not yet decided to develop a case to get clubs exemption from income tax and therefore has not asked for any funds.

Combined Council News: There was discussion on ensuring Combined Council information got to all club members. Delegates reported that some club magazines publish Combined Council news while others do not. Delegates & club secretaries are asked to approach magazine editors with a view to having CC News published in their magazine.

Email of CC minutes: Only two additional clubs have provided Email addresses for CC Minute distribution. All clubs are again asked to consider providing Combined Council with one or a number of Email addresses for the distribution of Combined Council minutes and other information.

Carbon Foot Print: It was suggested that clubs consider approaches to show that the old vehicle movement is concerned with Climate Change. A suggestion was made that clubs consider planting trees to achieve a carbon offset for the carbon emissions that our vehicles make. The National Motoring Heritage Day in 2008 was considered an ideal opportunity to demonstrate our concern for the environment. Clubs were advised that most Councils will provide trees for free for such events.

Club of the Month: After some discussion David James moved that at each Combined Council meeting a club delegate address the meeting to tell other delegates/clubs about their club's activities and aims. It was considered that this will better inform clubs about what is happening in the wider older vehicle movement. The Historical Motorcycle Club and the Austin Motor Vehicle Club delegates will do a presentation at the January meeting. Key aspects of 'club of the month' news will be included in CC News.

100 Year old Vehicles: The Minister for Transport is to present 18 owners of vehicles over 100years old with commemorative medallions at a function at the Veteran Car Club Rooms 1376 Old Cleveland Road on the 23rd November. Mr. Brooks was interviewed on ABC radio today to help publicise the event.

QUEENSLAND TRANSPORT:

The Combined Council will approach the Minister for Transport if Queensland Transport again fails to deliver on their promise to present the findings of the SIVS review to Combined Council for our clubs input, by the February deadline. While Combined Council considers that there are unlikely to be adverse effects of the review, we are keen to have the review finalised.

NATIONAL MOTORING HERITAGE DAY– a salute to Australian motoring.

All Clubs are again asked to consider volunteering as a **host club** to organise a regional or area event for National Motoring Heritage day on the 18th May 2008. Combined Council will help publicise the events. With a number of clubs organising events in each region and with members of other clubs invited, the Old Vehicle Movement will get excellent publicity.

At the November Combined Council meeting delegates recommended that clubs consider “Planting Trees” at National Motoring Heritage Day activities to demonstrate that our movement is concerned with and taking action to combat Climate Change by off setting the carbon emissions.

Publishing Combined Council New: Combined Council Delegates recommended that club magazine editors publish edited versions of CC News in club magazines.
